Why consider a gift in your Will?

- Create lasting impact through bursaries and scholarships for young women who might not otherwise access university and college life
- Strengthen student wellbeing, leadership and academic support
- Contribute to safe, contemporary accommodation and vibrant communal spaces
- Honour someone special through a named bursary or memorial gift

Ways to leave a gift

Leaving a gift in your Will is straightforward and flexible. You can choose the form that best reflects your wishes:

Residual gift

I give the residue [or ____% of the residue] of my estate to Duchesne College (ABN 79 400 739 310) for its general purposes or for the Bursary Endowment Fund / scholarships and bursaries / building and campus renewal / {named fund}. The receipt of the Head of College and Chief Executive or other authorised officer shall be a full and sufficient discharge to my executors.

Percentage gift

I give ____% of my estate to Duchesne College (ABN 79 400 739 310) for its general purposes or for {purpose as above}. The receipt of the Head of College and Chief Executive or other authorised officer shall be a full and sufficient discharge to my executors.

Pecuniary gift (fixed amount)

I give the sum of AUD \$[amount in figures and words] to Duchesne College (ABN 79 400 739 310) for its general purposes or for {purpose as above}. The receipt of the Head of College and Chief Executive or other authorised officer shall be a full and sufficient discharge to my executors.

Specific gift (asset)

I give [description of asset] to Duchesne College (ABN 79 400 739 310]) for its general purposes or for {purpose as above}. The receipt of the Head of College and Chief Executive or other authorised officer shall be a full and sufficient discharge to my executors.
